课程描述

本课程将以近现代中国社会历史变迁为主线，引导同学们结合宏阔的社会历史过程、重大社会事件、重大社会现实问题，探讨社会分层与流动机制的重要转变及其对代际、代内流动的影响，从而更为系统地理解现实社会过程中的社会开放性或社会封闭特征的演变趋势。

This course is a post-graduated level seminar on social stratification which will offer an introduction to major issues and its impact on social stratification and social mobility in contemporary China. This course draws broadly works from social sciences research on China with a thematic discussion of some major issues in socialist and post-socialist Chinese society, specially focusing on social changes since 1978. Furthermore, we will pay much more attention on the impact of those important social changes on intergenerational mobility.
